## 2024 Finance Committee Report

On November 20, WM Stephen Petri appointed a Finance Committee consisting of Brother William Tracey, WB Felix Lugo, and this writer as chair.

We examined the ledgers of WB Adam Ellyson, Secretary, and Brother Sam Maurer, Treasurer.

For Income, we found a difference of \$33.

- Adam has +\$8,519
- Sam has +\$8,552 (Sam has some large transfers that I am excluding from this "Transfer from FCS +\$108,000 & Transfer from Fellowcraft club +\$3,474
  - So outside of the transfers on Sam's side, they basically reconcile.

For Expenses, we found a difference of -\$7,358.

- Adam has -\$13.260
- Sam has -\$20,618 (this is excluding a transfer of -\$100,000 to LPL Financial)
